Article 3

Current rules and resolutions not contradicting the provisions of this Resolution shall remain effective, as well as resolutions organizing allocation of housing to employees, until the issue of replacing resolutions

Article 4

The UAE Attorney General and Chairman of Federal Supreme Court shall be granted the increase of 70% determined by virtue of the above Cabinet Resolution No (9) for 2008, and Cabinet Resolution No (35) for 2009, respectively for the previous period, as of the date upon which the resolution organizing the increase percentage was issued,

Any decision or provision contradicting the provisions of this Resolution shall be repealed. <u>Article 5</u> Notwithstanding the provisions of the above Article (4), this Resolution shall come into force as of 01.01.2012, and shall be published in the official gazette
