



Circular No. (20) of 2022 Regarding the Issuance of Entrepreneurship Leave for Self-Employment in the Federal Government

To all Ministries and Federal Authorities,

The Federal Authority for Government Human Resources (FAHR) extends its warmest greeting to you, wishing you continued progress and welfare.

Pursuant to the issuance of Cabinet Resolution No. (30/7f) of 2022 regarding special terms and conditions for granting the UAE national employees in the federal government an Entrepreneurship Leave for self-employment, which will be applied as of January 2, 2023. The resolution aims to empower national cadres and talents and motivate them to embark on the world of entrepreneurship, explore its fields, which

will reflect positively on the future of national economy.

Based on the same resolution, a set of guides has been developed to enable ministries and federal authorities to understand the provisions contained in the above-mentioned solution: These guides include:

1. The Federal Authorities Guide regarding granting the UAE national employee an resolution. These guides include:

Entrepreneurship Leave for self-employment: which aims at the following:

- Setting terms and conditions related to granting an Entrepreneurship Leave for self-employment.
- Explaining all procedures to be followed by the employee while applying for an Entrepreneurship Leave for self-employment.
- Supporting federal authorities when considering leave requests submitted to them by any of their UAE national employees
- Clarifying the percentages related to the number of employees who may be granted this leave in the relevant federal entity.
- 2. Projects Guide for granting Entrepreneurship Leave for self-employment to **federal government employees:** which aims to achieve the following:

- Enabling stakeholders in the federal authorities to realize the classification of projects and economic establishments according to the legislation applicable in the country.
- Encouraging UAE national employees to set up and manage their own projects in the private sector.
- Establishing the foundations and criteria by which federal authorities can evaluate applications for Entrepreneurship Leave for self-employment.

3. Guide to the procedures for applying for an Entrepreneurship Leave for selfemployment in the Human Resources Information System in the Federal Government "Bayanati"

In order to enable the federal authorities to take the necessary measures regarding putting the guides into practice, FAHR will organize a series of virtual workshops for all federal government employees with the participation of the most important entrepreneurs in the economic sectors in the country to talk about their experience in the field of entrepreneurship according to the details shown below:
